REQUEST FOR TENDER Boot Point / Spring Bay Regional Park Lasqueti Island Park Contract Caretaker

INTRODUCTION

Boot Point Regional Park and Spring Bay Regional Park are both located on Lasqueti Island, on Spring Bay Road. The qathet Regional District (qRD) proudly manages these public parks and they are provided through permits and leases from the Province of BC.

The qRD invites tenders to provide caretaker services at Boot Point and Spring Bay Regional Parks.

Tenderers, by submitting a response to this Request for Tender (RFT), agree to the terms and conditions contained herein.

The qRD acknowledges that each Tenderer may or may not have the exact skills, qualifications, permits, certifications, etc. required to operate and manage the park. Some flexibility will be given with respect to the required duties. The qRD will work with the chosen tenderer, of whom will take on the position title of Contract Caretaker, to assist in meeting any shortcomings.

A. INSTRUCTIONS TO TENDERERS

1. Site Visit

A self guided site visit is recommended before placing a bid. A location map for the Boot Point and Spring Bay Regional Parks is attached as Appendix B. **This site visit is not mandatory.**

2. Submission of Tenders

- a. If you intend to submit a tender in response to this RFT, the attached Appendix A **Registration of Intent to Respond form** must be submitted no later than 4:00 pm on August 7, 2024, to ensure that you receive any addenda or other correspondence related to this RFT. - a. The qRD reserves the right to waive informalities in any bid; or to reject any or all bids; or to accept the bid deemed most favourable in the interests of the qRD.
- b. The contract award shall be made on the bid that will give the greatest value based on experience, quality, service and price.
- c. The lowest or any bid will not necessarily be accepted.

The qRD makes no representation or warranty as to the accuracy or completeness of the information contained in this RFT, and the Tenderer is solely responsible to ensure that it has obtained and considered all information necessary to understand the requirements of the RFT, and to prepare and submit its Tender. The qRD will not be responsible for any loss, damage or expense incurred by a Tenderer as a result of any inaccuracy or incompleteness in this RFT or as a result of any misunderstanding or misinterpretation of the terms of this RFT on the part of any Tenderer.

	EAS the qRD is the managing body of the parks located on Lasqueti Island, which are ally known and referred to as Boot Point Regional Park and Spring Bay Regional Park;
	HEREAS the qRD requires the services of a Contract Caretaker to operate and manage rks on its behalf;
	HEREFORE THIS AGREEMENT WITNESSES that the parties hereto mutually covenant be as follows:
	Subject to the terms and conditions of this Agreement, the term of this Agreement is from September 1, 2024 through to August 31, 2025 thereby establishing a 12 month contract with the aution to renew when agreement of both parties.
	with the option to renew upon agreement of both parties. The qRD agrees to pay the Contract Caretaker in exchange for services rendered as follows:
	The sum of \$ per month for the period.
(The monthly payment will be inclusive of all taxes that may become payable by the Contract Caretaker as a result of this contract. In other words, there will not be any additional monies paid to the Contract Caretaker for taxes.
-	The Contract Caretaker will be responsible for all of their own vehicle, fuel and

transportation costs.

The Contract Caretaker will be **responsible for their own WorkSafeBC** coverage as well as WorkSafeBC coverage for their relief caretaker (s) while working under this contract. Proof of WorkSafeBC coverage must be made available to the QRD prior to the finalization of the contract.

The Contract Caretaker, at their own expense, **must carry comprehensive general liability insurance** coverage in the minimum of two (2) million dollars and shall include the qRD as a named additional insured. Certificate of insurance must be made available to the qRD prior to the finalization of the contract.

3. The Contract Caretaker covenants with the qRD:

- a. to provide caretaker services during the term of this Agreement, subject to the further conditions provided herein;
- b. in particular, to provide the services set out in Schedule "A" attached hereto and forming part of this Agreement;
- c. to ensure that the Contract Caretaker visits each park weekly during the period of June 1 through September 1 weekend; and fortnightly September 1 to May 31.
- d. to advise the qRD when a relief caretaker is appointed from time to time and to seek the qRD's prior approval as to the candidate and the length of time involved;
- e. to be responsible for all expenses of, and fees payable to a relief caretaker;
- f. to provide equipment required to do grounds maintenance as outlined in Schedule "B" attached hereto and forming part of this Agreement.

4. The qRD covenants with the Contract Caretaker:

- a. to be responsible for major repairs and structural maintenance of roads, trails, and signs within the parks, including painting as the qRD deems necessary; and
- b. to provide capital improvements to the grounds and buildings as the qRD deems necessary, and to supply labour and materials for special projects that are approved by the qRD.

5. Termination

- a. This Agreement may be terminated in the event that the contract is breached by either party, in which case notice may be served by one party to the other, advising of the nature of the contract provision which has not been adhered to, and the Agreement shall be considered terminated thirty (30) days following the effective date of service.
- b. Notwithstanding any other provisions of this Agreement, either party may at any time during the term of this Agreement terminate this Agreement upon ninety (90) days written notice served to the other party.
- c. Any written notice to be served upon or given to either party to this Agreement shall be sufficiently served and given if delivered or mailed, prepaid and registered, addressed to the party concerned at the addresses set out on page one (1) of this Agreement or to another address a party may designate in writing. Any notice is deemed given and received, if delivered by hand, on the day delivered and, if mailed upon the expiry of four (4) days after the mailing thereof.

LAQUETI ISLAND PARKS CONTRACT CARETAKER

Contract Caretaker Duties – including but not restricted to the following:

Maintenance:

- 1. Performs grounds maintenance within the park areas including trails and picnic areas. Grounds maintenance in these areas includes but is not limited to weed and grass cutting, all season leaf and branch removal, weed control, and grass re-seeding.
- 2. Performs a weekly inspection of the park, to ensure general cleanliness and safety of all areas. In particular, any items (including glass and needles) that may pose a hazard or be unsightly shall be immediately removed and disposed of in a safe manner.
- 3. Reports any grounds maintenance concerns to the qRD ,Manager of Operational Services and provides input that will enhance the quality of service to the park patrons.
- 4. Operates a variety of gasoline, diesel, and electrical equipment.
- 5. Fills potholes in roadways and trails.
- 6. Keeps brush cut back from roadways and trails.
- 7. Clears roads and trails blocked by windfalls.
- 8. Utilizes safe work practices, complies with health and safety legislation, and the qRD safety program.
