



## **Shelter Point Park / Haywire Bay Park Summer Youth Worker**

The qathet Regional District (qRD) is accepting applications from persons aged 15 to 30 interested in working at either Shelter Point Regional Park and Campground on Texada Island, or Haywire Bay Regional Park and Campground for the 2026 summer season.

The positions are ideal for someone participating in a post-secondary education program and interested in working during their free summer term, but are open to all youth aged 15 to 30 under the terms of the Government of Canada *Canada Summer Jobs Program*.

This role reports to the appropriate Park Caretaker and Parks and Properties Supervisor, and will be assisting with a range of day-to-day activities within the park.

### **KEY DUTIES AND RESPONSIBILITIES** *include the following:*

- Perform general building and grounds maintenance work such as janitorial tasks, general grounds maintenance, and painting.
- Operate a variety of gasoline, diesel, and electrical equipment.
- Utilize safe work practices and comply with health and safety legislation.
- Maintain professional, courteous, and positive public relations with the public, contractors, and representatives of various agencies.
- Follow all policies, procedures, and standards of the Regional District.
- Perform other related duties as assigned.

### **QUALIFICATIONS / REQUIREMENTS:**

The requirements listed below are representative of the knowledge, skill, and ability required to perform the duties of the position satisfactorily.

#### **Education / Training / Experience**

- Youth aged 15 to 30, preferably with Grade 12 or equivalent
- Must have own transportation to and from work
- Familiarity with basic maintenance tools and equipment
- Excellent interpersonal and communications skills and the ability to deal with people in a professional and courteous manner.
- Ability to work with minimum of supervision.
- Excellent attention to detail.
- Sufficient physical strength, stamina, and co-ordination to meet the requirements in all weather conditions.
- WHMIS Training (qRD will provide)

#### **Schedule of Work**

This is a part-time position covered by a Collective Agreement with CUPE Local 798. Work schedule is 7 hours per day, 5 days per week, with 2 consecutive days off. Park employees **must** work weekends and holidays.
